## 4. First-Aid Measures

**First Aid - Eye Contact:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

**First Aid - Skin Contact:** Remove contaminated clothing. Wash skin with soap and water. Get medical attention. Immediately flush skin with plenty of water for at least 15 minutes while removing clothing. Get medical attention immediately. Wash clothing separately before reuse. Wash contaminated clothing and decontaminate footwear before reuse.

# 5. Fire-Fighting Measures

**Unusual Fire and Explosion Hazards:** Closed containers may explode when exposed to extreme heat due to buildup of steam. Vapors can travel to a source of ignition and flash back. Combustion generates toxic fumes of carbon monoxide, carbon dioxide and other gases. Keep containers tightly closed. Combustible liquid and vapor.

## 6. Accidental Release Measures

Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools.

# 7. Handling and Storage

Handling: Wash thoroughly after handling. Wash hands before eating. Remove contaminated clothing and launder before reuse. Use only with adequate ventilation. Follow all SDS and label precautions even after container is emptied because it may retain product residues. Ground and bond containers when transferring material from one vessel to another. Vapor can be ignited by static discharge. Avoid breathing fumes, vapors, or mist. Avoid prolonged or repeated contact with skin. Avoid contact with eyes, skin and clothing.

**Storage:** Store in a dry, well ventilated place. Keep container tightly closed when not in use. Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Keep away from heat, sparks, flame and sources of ignition. Avoid excess heat.

## 10. Stability and Reactivity

# 11. Toxicological Information

Effects of Overexposure - Eye Contact: Causes eye burns. Irritating, and may injure eye tissue if not removed promptly. High vapor concentrations can irritate eyes, nose and respiratory passages.

**Effects of Overexposure - Skin Contact:** Prolonged or repeated skin contact may cause irritation. Contact causes skin irritation. Substance is corrosive. Causes severe skin burns. Causes skin irritation. Allergic reactions are possible. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material. Frequent or prolonged contact may irritate the skin and cause a skin rash (dermatitis). Severely irritating; may cause permanent skin damage.

Effects of Overexposure - Inhalation: High gas, vapor, mist or dust concentrations may be harmful if inhaled. Avoid breathing fumes, spray, vapors, or mist.
