4. First-Aid Measures

Effects of Overexposure - Chronic Hazards: High concentrations may lead to central nervous system effects (drowsiness, dizziness, nausea, headaches, paralysis, and blurred vision) and/or damage. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of carbon black in the formula. IARC lists Ethylbenzene as a possible human carcinogen (group 2B). Prolonged or repeated skin contact may cause dermatitis.
